a) Is or has ever been convicted of an offence involving dishonesty as defined in section 2(1) of the Crimes Act 1961, or an offence under section 373(4) of the Companies Act 1993 (unless that person is an eligible individual for the purposes of the Criminal Records (Clean State) Act 2004

b) Is bankrupt or has made any composition or arrangement with his or her creditors;

c) Has been convicted of an indictable offence (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004; or

d) Is subject to a compulsory treatment order under the Mental Health (Compulsory Treatment and Assessment) Act 1992 or is subject to a care and protection order under Protection of Personal and Property Rights Act 1988;

e) Has within the last three (3) years been removed from the office of Trustee, in accordance with clause 22.3.

f) Has been removed as a director or trustee of any other company, entity or trust, by order of any Court in New Zealand.
