c) Has been convicted of an indictable offence (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004; or
d) Is subject to a compulsory treatment order under the Mental Health (Compulsory Treatment and Assessment) Act 1992 or is subject to a care and protection order under Protection of Personal and Property Rights Act 1988;
e) Has within the last three (3) years been removed from the office of Trustee, in accordance with clause 22.3.
f) Has been removed as a director or trustee of any other company, entity or trust, by order of any Court in New Zealand.
